

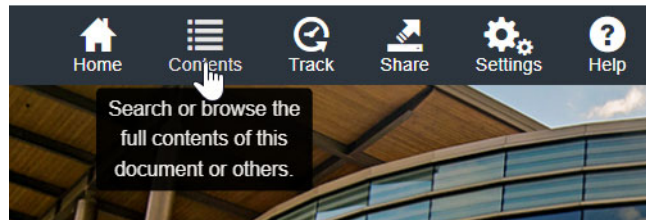

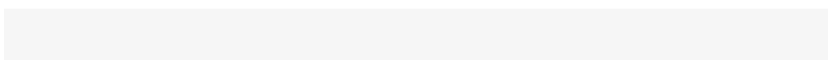

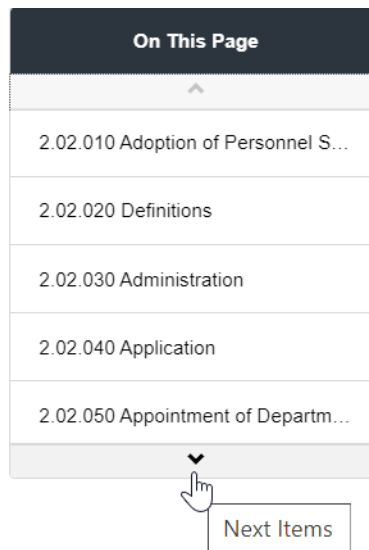

- In the What's Nearby area, clicking on the title or chapter will take you to that title or chapter.



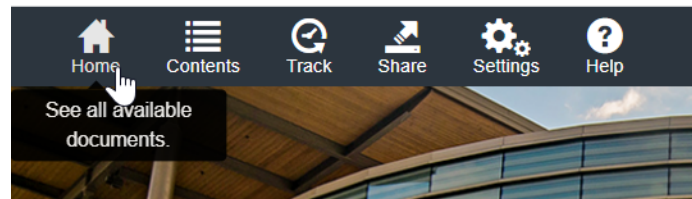

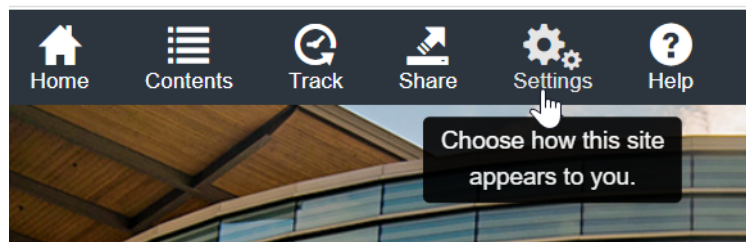

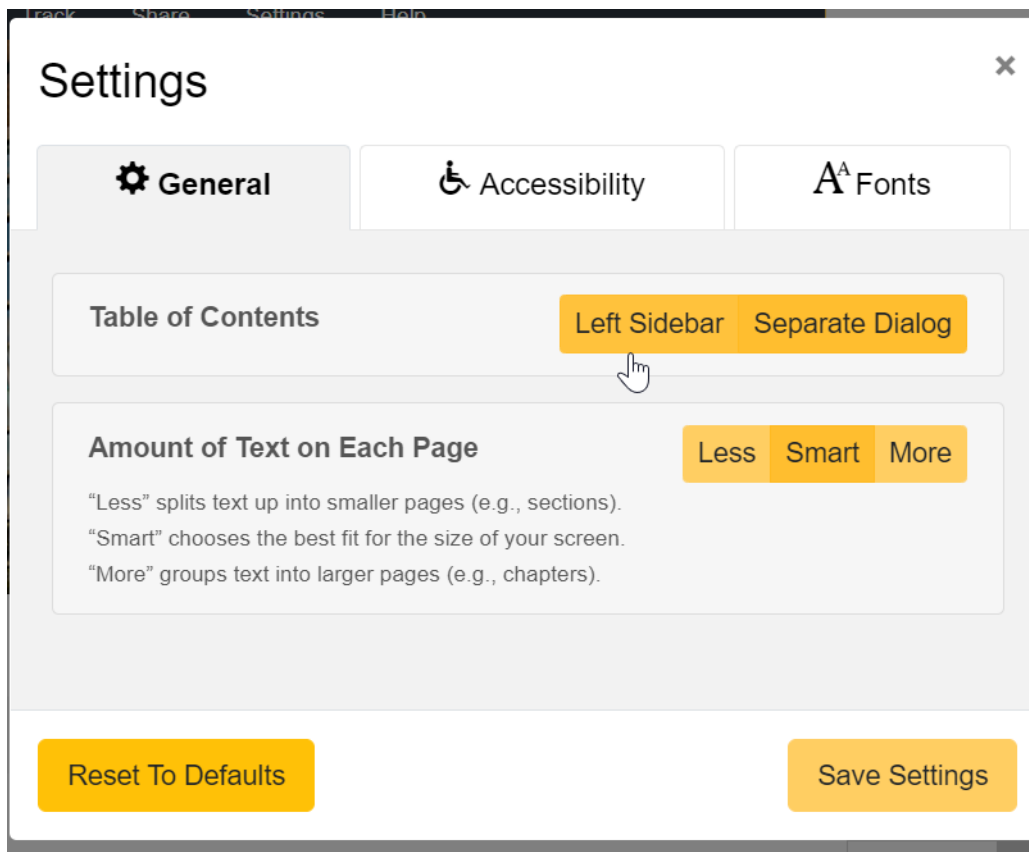


Settings dialog

Searching a code

- Enter a search term in the space provided and click the **Search** button. This will return a list of the pages that match your request in order of relevancy. To view a document in the list, click on the link.



- Exact/Narrow/Smart/Broad/Broader options.** As the title implies, from Exact to Broader will change the results. Smart is the default; if you want an “exact” match, choose that option. “Broader” will most likely provide too many results.

Scope Searching — Restrict a search to specific titles or documents.

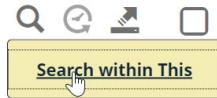

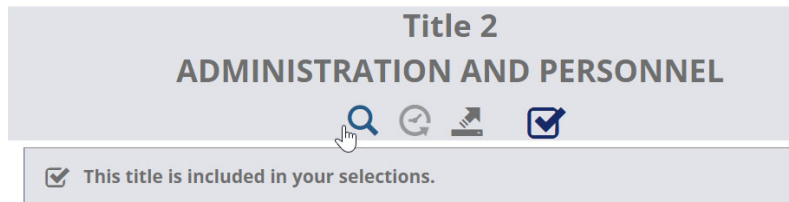

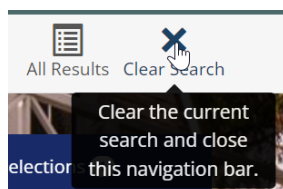
Clicking the blank box, then clicking the magnifying glass will restrict the search to that title or chapter:



- After you have opened a matching document, you can use the **2 of 18 items** (of all results) or **1 of 2 matches** on the page on the top navigation bar to navigate from hit to hit.



- Clicking "All Results" returns you to the results page. Clicking "Clear Search" cancels the search.



Advanced Search Options — Boolean Searching

Use Boolean searching to refine the search with stemming, phonic searching, etc. There are several search options. Trial and error will help you decide which is best for your search.

Boolean is ideal for finding more precise results. Boolean search is available by opening the "Advanced" button and clicking on Boolean. A Boolean search will automatically run from the main toolbar if you use Boolean wildcards.

A Boolean search request consists of words or phrases linked by connectors such as “and” and “or” that indicate the relationship between them. Examples:

apple and pear	Both words must be present
apple or pear	Either word can be present
apple w/5 pear	Apple must occur within 5 words of pear
apple not w/5 pear	Apple must not occur within 5 words of pear
apple and not pear	Only apple must be present

If you use more than one connector, you should use parentheses to indicate precisely what you want to search for. For example, apple and pear or orange juice could mean (apple and pear) or orange, or it could mean apple and (pear or orange). Noise words, such as if and the, are ignored in searches.

Search terms may include the following special characters:

?	Matches any single character. Example: appl? matches apply or apple.
*	Matches any number of characters. Example: appl* matches application.
~	Stemming. Example: apply~ matches apply, applies, applied.
%	Fuzzy search. Example: banana matches banana, bananna.
#	Phonic search. Example: #smith matches smith, smythe.
~~	Numeric range. Example: 12~~24 matches 18.
:	Variable term weighting. Example: apple:4 w/5 pear: 1

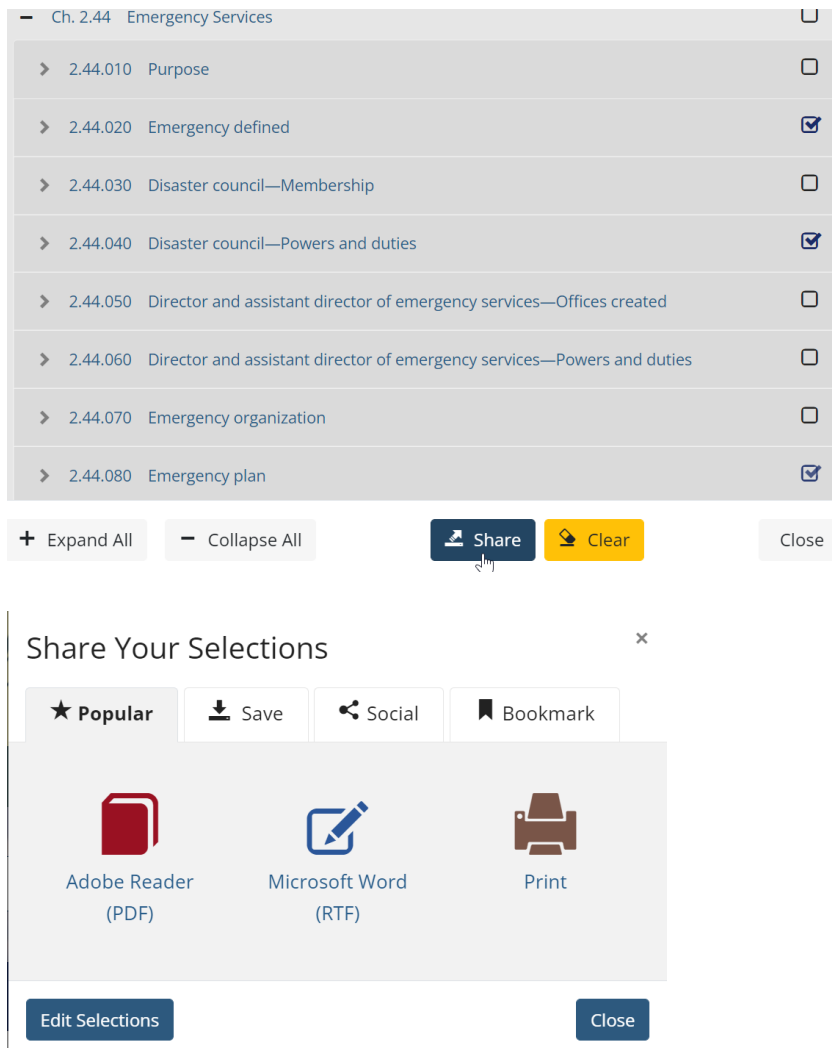
Printing or saving selections

You can select any combination of titles, chapters, and sections to print or to save in a variety of formats. Use the Contents window to select or while browsing the code, click the check box next to the title, chapter or section you want to print or save.

- **Selecting Material:** Expand the table of contents by clicking on the plus (+) symbol next to any title or chapter that you would like to open. Click on the check boxes beside the titles, chapters, or sections that you want to print or save.

You can select multiple titles, chapters and sections at once. To deselect, click the check box again. To deselect everything you have selected, click on **Clear all** at the top of the table of contents.

- When you have made your selections, click the **Share** button at the bottom of the table of contents. Then click Popular, Save, Social or Bookmark. Choose the format you want.



- **Printing:** Click the **Print** button in the popup window. Your browser's print dialog will appear. (Alternatively, you can browse to the chapter you want to print and click the **Print** link at the top right of the main code window.)
- **Saving:** Choose a file format from the dropdown menu in the popup window, then click the **Save** button to download the file. The default format is **RTF**; this lightweight format can be opened in most word processors (Microsoft Word, WordPerfect, etc.). You can also choose a preformatted document in **PDF** (for Adobe Reader) format. Files are saved to the "Downloads" folder on your computer.
- **Saving as Word/RTF:** If saving your selections to Word/RTF shows an error after more than a minute, the graphics or tables in that part of the code may prevent saving in this format. When this happens, save the text to PDF, then open the PDF and export to Word/RTF. The results are about the same as when saving directly to Word/RTF.



1. Type 1 Amendment

Type 1 amendments involve significant changes to the Town's General Plan.

Type 1 amendments are defined as major General Plan amendments in State law and involve a substantial alteration of the Town's land use mixture or balance. A Type 1 amendment shall be required for any of the following substantial alterations to the General Plan:

- a. Any change to the Land Use Plan that affects forty (40) acres or more and is classified as a Type 1 amendment on the General Plan Amendment Matrix (Table 22-1).
- b. Increasing the amount of High Density Residential, regardless of acreage.
- c. Increasing the amount of Master Planned Community, regardless of acreage.
